



MEMORANDUM OF UNDERSTANDING

Between:

**HEAVENLY CULTURE, WORLD PEACE,
RESTORATION OF LIGHT**

And

**STATE ISLAMIC UNIVERSITY
SUNAN KALIJAGA YOGYAKARTA**

I. BACKGROUND

This is a Memorandum of Understanding (“MOU”) between Heavenly Culture, World Peace, Restoration of Light (“HWPL”) and State Islamic University (UIN) Sunan Kalijaga Yogyakarta (“Party B”), hereinafter jointly referred to as “the Parties,” regarding their collaboration to achieve shared objectives relating to the achievement of peace and cessation of war.

II PARTIES

- A. HWPL is a non-governmental, non-profit organization registered under the Korean Ministry of Foreign Affairs. HWPL transcends differences in culture, belief and religion to engage leaders and youth in sustainable and comprehensive solutions for peace. HWPL strives to foster an attitude of peace modelled after heavenly culture, where the values of love and respect are shared abundantly and without discrimination, just as the heavens provide light, air, and rain abundantly and without discrimination for all to live. Through this model of peaceful coexistence, HWPL strives to repay the blood lost in countless wars before us through a new generation of peace.

- B. Universitas Islam Negeri (UIN) Sunan Kalijaga Yogyakarta is a national university representing Yogyakarta, Indonesia. The university strives to create an educational atmosphere to improve the high quality of higher education and quality of life of the community, and puts an effort into education and research reflecting the ability to integrate the values of Islamic teachings with science, technology, and so on.

III PURPOSE & SCOPE

- A. The purpose of this MOU is to establish a framework of understanding between the Parties in order to carry out HWPL peace projects together with Party B with the aim of achieving a common purpose.

- B. The purpose of this MOU is to ensure a close cooperative relationship between the Parties to provide the HWPL peace education to students of Party B based on mutual respect and trust.

IV AGREEMENT

A. HWPL

1. HWPL shall provide education materials for the operation of the peace education.
2. HWPL shall provide appropriate training for the peace education officers and teachers.

B. Target school principal(s)

1. They shall provide basic infrastructure for the operation of the peace education.
2. They shall hold all authorities and responsibilities in implementing the education as supervisors who oversee the peace education.
3. They shall designate teachers to be in charge of providing the peace education.

C. Implementation period of each activity shall be determined under negotiations between the Parties.

V TERMS OF UNDERSTANDING

A. **Effective Date:** This MOU will be effective from the date following the day on which the agreement is signed.

B. **Duration:** The MOU shall be in force until the Parties agree to terminate it in writing.

C. **Modification:** The MOU may be modified or amended by written agreement between the Parties. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon by and between the parties to this MOU shall be incorporated by written instrument, and effective when executed and signed by both Parties to this MOU

D. **Termination:** Each Party shall have the right to terminate the MOU by giving a three month's written notice to the other Party at any time. If the MOU is terminated by either Party, steps shall be taken to ensure that the termination does not affect any prior obligation, project or activity already in progress.

VI CONFIDENTIALITY

The Parties shall treat as confidential all confidential information obtained by the Parties in connection with the MOU and agree to not divulge any information to any other person.

VII REPORTING

The principal(s) or peace education officers have the duty to report operating processes and results of the HWPL peace education to HWPL after each class.

VIII FINANCE

The Parties agree that the HWPL headquarters has no financial duty towards the operation of the peace education.

IX SIGNATURE

The Parties indicate their agreement with this MOU by their signature.




